1. What is in the draft EIR

As you are likely aware, the draft Environmental Impact Report for the Arcata General Plan Update (including the Gateway Area Plan) is now available for viewing. The public comment period is from the current date through 5 p.m. March 18, 2024.

The draft EIR document is based on the presumption that the population of Arcata will grow to be 40% greater (about 7,500 people) than a 2020 baseline by the year 2025. This corresponds to a population of about 18,860 in 2020, about 19,600 in 2023, and 26,400 in 2045. Students living in Cal Poly-supplied housing would be **in addition** to these figures.

In this draft EIR, because the document's Table of Contents, list of Figures, and list of Appendices is quite minimal (and as such is of very limited value, in my view), I have made a Table of Contents that is more thorough. I'll be posting this, along with other documents, on the Arcata1.com website over the next few days. If you want, I can send it to you directly. Without a good table of contents, it can be difficult to locate important areas.

I'm including in this message the page numbers of items that I believe would be of interest to you. There will be other areas of the draft EIR of interest to you too. Included here are the more obvious ones.

I'll also be breaking up the 1,990 pages into segments to make it more manageable to the reader. I'll likely have a segment on fire safety, because of its importance.

The following pages are connected with the AFD and your services. The page numbers here are the page in the document (chapter and page) and the PDF page number. (I find that using the PDF page number to be far more useful.)

• Letter from Chief Justin McDonald to David Loya, February 24, 2022. Response to the Notice of Preparation (NOP) of the EIR. (Shown in Appendix B (no page numbers); PDF pages 625 and 626.) Note: As shown, this letter is not complete. The full letter is not there. It is possible that a portion of the letter is shown on page 635. There are four images listed in the cover memo shown on page 626 -- those four images are missing. Even with the contents of pages 625 and 635, this letter does not seem complete.

[A request: Could you forward this complete letter and images to me. Thank you.]

• Evaluation Criteria and Significance Thresholds: 3.10.4. (Page 3.10-40; PDF page 307.) Impacts and Mitigation Measures is 3.10.6. (Page 3.10-41; PDF page 308). This is the crucial area of the draft EIR for fire protection service.

The draft EIR states:

Mitigation Measures: No mitigation is necessary Level of Significance: Less than significant impact

- "Fire Protection within the Study Area" (Starts at 3.10-1; PDF page 268.) This is a little over one page in length.
- Section 3.10.3 is "Regulatory Framework." (Starts at 3.10-8; PDF page 275.) It shows the "National Fire Protection Association Codes and Standards" for fire response. The following page mentions:

 State Title 8 Sections 1270 "Fire Prevention" and 6773 "Fire Protection and Fire Equipment"

- California Code of Regulations Title 24 (California Building Standards Code) Part 9 (California Fire Code)
- o California Health and Safety Code Division 12 (Fires and Fire Protection)

- And more.
- City guidelines for Fire and Emergency Preparedness. (Starts at page 3.10-13; PDF page 280.)
 "All fire protection and prevention duties, except those hereinafter mentioned, within the City of Arcata have been and continue to be the responsibility of the Arcata Fire Protection District."
- Page 3.10-31 (PDF page 298.)
- Table 3.10-2: Annual Call Volume Since 2008 and Response Times within the City Limits. (Page 3.10-2; PDF page 269.)
- Statement attributed to Justin McDonald: NFPA standard is not used as level of service thresholds. (Page 3.10-41; PDF page 308.)
 Draft EIR states: "Both the City and AFPD do not have an established level of service expected for fire protection services."
- Table 3.10-7: NFPA 1710 Deployment Models and Common Local Deployment Strategy. Showing personnel requirements for varying critical tasks. (Page 3.10-42; PDF page 309.)
- Statement attributed to Justin McDonald on Response Times.

 Draft EIR states: "Therefore, response times are not anticipated to increase based on call distance from the station." (Page 3.10-43; PDF page 310.)
 - Statement attributed to Justin McDonald on responses to vegetation fires. (Page 5.7-2; PDF page 525.)
 - AFD is cited as a reference. "2016. Summary of PPC Review For Arcata FPSA" (Page 3.10-53; PDF page 320.)

Other items to note:

- The word "fire" is in this document 668 times or so. In addition, the word "wildfire" is there 138 times or so.
- The Hazards and Hazardous Materials section is at 3.6-1 (PDF page 175).
- Toward the bottom of page 1.0-13 (PDF page 19) are two questions on the summary of impacts and mitigation measures for Hazardous Materials.
- "Fire Hazards" is at 3.6-9 (PDF page 183). It is one paragraph that, to me, says very little.

One of the questions on the impacts of the planned growth on Fired Protection. The Impact question is on Page 3.10-41 (PDF page 308). Highlights added in bold.

Impact PSR-a1: Would adoption and implementation of the General Plan result in substantial adverse **physical impacts** associated with the provision of new or physically altered

government **facilities**, need for new or physically altered governmental facilities, the construction of which could cause significant environmental impacts, in order to maintain acceptable service ratios, response times or other performance objectives for fire protection?

These two paragraphs below are a part of the reply to that Impact question. Highlights added in bold.

While AFPD may not have adequate staff, training, or equipment to serve the full buildout of the General Plan 2045, those have been determined to not result in the need for renovated or new facilities because no new training facilities are needed, and current facilities could accommodate additional staff and equipment. AFPD's existing facilities will remain sufficient to adequately serve the 2045 projected population within its existing service area based on staffing levels, equipment needs, and response times from existing stations.

The adoption and implementation of the General Plan 2045 may result in an increase in the number of calls for service, placing a greater demand on fire protection services. In order to maintain current response rates, a new facility or substation may be required if call volume increases and call distribution changes significantly. The City and AFPD would need to continue monitoring and review call volumes, call distributions, and response times to determine adequate level of service or if a new facility should be constructed. The growth anticipated in the General Plan 2045 could potentially result in the need for new or expanded fire protection facilities. The exact location and extent of facility improvements or expansion is not known at this time and would likely be based on future call distribution in order to most effectively serve the community. AFPD would be required to address the potential environmental impacts of the development of additional or expanded fire facilities at that time. As a programmatic, policy-level analysis, the adoption and implementation of General Plan 2045 would not result in significant environmental impacts caused from the alteration and construction of fire protection facilities to maintain acceptable service ratios and response times. Impacts would be less than significant.

Mitigation Measures: No mitigation is necessary Level of Significance: Less than significant impact

2. My views and opinions

Based on the contents of the draft EIR found on pages 3.10-41 through 44 (PDF pages 308-311) it seems that we are seeing something similar to what was presented in the draft EIR for the Craftsman Mall dorms. Namely that the EIR question is only about the physical facilities of the AFD -- the buildings. Matters such as response time and personnel requirements are not part of the EIR process.

To me, this approach to the issue really misses the point. In terms of CEQA requirements, this narrow view fulfills the law. In terms of the real-life situation of providing fire safety and protection, to reduce the issue of fire protection to one of "is your station large enough" is essentially a sham.

Perhaps the Arcata City Council will request a more real-world assessment of what's involved in providing adequate fire protection and emergency response times.

I am hopeful that the study commissioned by yourselves, the university, and the City will bear fruit and help create some meaningful change. You likely will not have the results from that study by the time that the Arcata City Council approves this draft EIR, however. We all want the many specific areas of concern to be resolved in a way that is satisfactory to you.

Back in September 2023 I wrote an article of what I saw as the large issue of fire protection in the Gateway area, and wrote a possible solution. This article was not based on interviews with you -- just my ideas on the subject.

As a possible solution, my proposal was as follows. This is included in the September 2023 article:

Developers can design a four-story or taller building, get their funding, have the building approved, start construction and even complete the construction. But they will not be eligible to get a certificate of occupancy until the Arcata Fire District says it's okay. Whether that means the lower three floors of the building could have occupancy (with higher floors blocked off) or if the entire building cannot be occupied, I'll leave that to the AFD. And that could be a case-by-case decision, based on other fire-safety elements, such as number of stairwells, and so forth.

In theory, the AFD will have this matter of providing fire protection in taller buildings worked out over the next 2 to 5 years. And construction of apartments in Arcata might start to happen in about that same time-frame.
